The Following Conditions Need To Be Understood Before Enrolling:

1. **The course consists of 8 hours of instruction for over 19 years of age, at a cost of \$300.00.** Payment in full is to be made at the first session, unless other arrangements have been made.
2. Student will be notified by phone in the event the school cancels classes. Cancelled classes will be made up at the end of the course.
3. A refund of all fees paid will be made, upon request, if the school is not capable of or willing to begin instruction within 30 calendar days from the date agreed upon in the contract.
4. **This contract is valid for 90 days from the first classroom session.**
5. School does not guarantee that any student will pass the state license examination or that the student can secure a license, or that the student will be guaranteed employment upon completion of any course instruction.
6. A fifty dollar (\$50.00) fee will be charged for any non-sufficient fund or stop payment check that is returned by the bank. Issuer of the check will be responsible for legal expenses.
7. Replacement of DTC-B will be a \$20.00 processing fee.

8. Students are fully accountable for their conduct. Any damage done by a student to school property, building, or parking lot will result in the student being immediately dropped from the program with NO refund given. Any payment necessary for the damage will be the responsibility of the student. Criminal activity will be reported to the local authorities.

9. Sleeping, talking or cell phone use is not allowed during class lectures, videos etc... Anyone found sleeping, talking or using their cell phones during these times will be asked to leave and will not be given credit for their attendance.

10. All students hereby agree to keep areas in the building, classroom; parking lot and automobiles clean from litter and debris.

11. Any student suspected of being under the influence of alcohol or drugs while attending class or road instruction will be immediately dismissed from the program and the authorities notified. Also, No refund will be given.
